What efforts did the RAC make to maximize inclusion of its constituents into the RAC to continue to develop an integrated trauma system? All licensed hospitals, freestanding ER's, Rehab facilities and EMS providers identified in our counties are members of NETRAC. There was an effort to identify Nursing Home facilities but with no response or interest.
- Summarize the need for and outcomes of specially called RAC meetings. Finance and budget committee meetings were called, as well as a RAC Retreat in December, all had beneficial outcomes. Some were in-person and some were virtual.
- c. Report on any projected realignments of counties in trauma service area. Franklin County was added to our RAC per request of its County Judge and funding re-routing is now complete.
- Describe the RAC's role with facilities within the trauma service area prior to or during trauma center designations/re-designations that occurred within past twelve months. You may also describe RAC's role with facilities outside the trauma service area, if applicable. NETRAC acted as a resource for information related to updated program rules. NETRAC also provided guidance to hospitals to aid in the success of their designation efforts as well as funding for travel and training for program staff as needed

to ensure preparedness and maturation of trauma programs within the region. The RAC supports designation by providing Participation Letters when appropriate.

- e. Describe how the RAC administratively and operationally contributed to and participated in Injury Prevention initiatives within the past twelve months. Please provide a brief summary of all injury prevention activities describing the RAC's level of involvement. NETRAC budgeted funds for multiple educational trainings and equipment for regional program staff. We also budget for and participate in the RAC Data Collaborative (RDC) to assist with regional data. Regional data is used to plan regional injury prevention initiatives for all facilities to utilize. These initiatives and supplies are used at local community events for community education. NETRAC also contributed logistically and financially toward multiple Stop the Bleed courses taught across the region, as well as Car Seat Safety checks and seminars to the public.
- f. Describe the most significant findings of the RAC's SQI/Performance Improvement Committee within the past twelve months. What changed because of those findings? Stroke, trauma, and EMS committees are now collecting regional data and contributing to the injury prevention committee. The trauma committee is building a regional referral process for trauma cases, and the RAC is considering a system PI committee.
- g. To what degree were physicians in the trauma service area involved in the resolution of adverse patient care findings identified by the RAC's SQI/Performance Improvement Committee. Physicians were consulted and discussed any clinical concerns as needed. The perinatal group has historically been the most active. A physician from a free-standing ER has recently volunteered to become more active as well. Discussions are ongoing in consideration of a system PI committee.
- h. Describe activities the RAC was involved in that assisted or encouraged EMS and FRO participation in the RAC within the past fiscal year (e.g. teleconferencing, video/conference calls, etc.). We continue to offer both virtual and in-person meetings. All EMS providers are members, however FRO participation is sparse at best.
- i. Identify problems or areas of concern identified in the past twelve months adversely impacting RAC operations. With the addition of the EMS/RAC/EI funding, the decision was made to transition the ED to a full-time employee rather than a part time contract position. A lack of mentorship for a younger generation of members within the region has been a concern causing a difficulty with members fully understanding responsibilities and expectations. Better GETAC attendance and relationship building in other areas of the state is helping to improve this going forward.

SUMMARY OF REVISIONS/ADDITIONS: The bylaws were found to be old, outdated, and in need of major revision. Several examples from other regions were obtained as well as the DSHS example from their website. An overhaul of the bylaws was written with input and approval from the Board of Directors. They were reviewed by the Board of Directors and Executive Director at a scheduled RAC retreat. The new bylaws were sent to the General Assembly for review with a formal comment period. Several comments were received and included in the document. The bylaws were also reviewed by an independent legal service with minor edits recommended. A second formal comment period was offered without any input. Official review and approval were obtained by the Board of Directors and General Assembly with a unanimous vote of approval. The bylaws were then given a "go live" date and placed into effect.
